When billing on behalf of our clients, HT LOGISTIC SERVICES LLC will process all invoicing according to the customers instructions and follow up until payments are rendered to our clients.

II. Consideration

The client agrees to pay for services per schedule on the agreement. Payment for the basic Consulting Services, Dispatch Services and Billing Services are to be paid in advance of each billing cycle. Payment can be made to HT LOGISTIC SERVICES LLC by ACH/ Direct Deposit , ZELLE, PayPal (No PayPal account required), Money order, Credit/Debit card and cash. Any other provisions must be approved in advance. Please refer to the agreement for additional information.

III. Additional Provisions

- Once a load has been set up for the client and all information given, it will be the responsibility of the client to handle directly with the shipping party, any problems, issues, delays, overages, shortages, damages, or billing and collection issues;
- In no event will HT LOGISTIC SERVICES LLC be liable for any incidental, consequential, or indirect damages for the loss of profits or business interruption arising between parties;
- Client agrees, before, during and after the contract, all direct or indirect damages resulting from client hauling or shippers' freight. This includes, but is not limited to, loading problems or issues, delays, overages, shortages, damages, billing or collection issues, and hours of services;
- Client will be responsible for notifying HT LOGISTIC SERVICES LLC of changes to authority, insurance, client profile, or ownership;
- HT LOGISTIC SERVICES LLC will notify clients of load required qualification of insurance required
- Clients agree to pay HT LOGISTIC SERVICES LLC as agreed to in sections 1. and Attachment A of this agreement for services rendered. Note: To avoid charges for unavailable equipment, it is imperative to notify HT LOGISTIC SERVICES LLC immediately if available for any reason. No charge will result if HT LOGISTIC SERVICES LLC is notified that the truck is no longer available for dispatch.

IV. Disclaimer

HT Logistic Services, LLC is not responsible for:

- Billing issues;
- Load Problems of any nature;
- Advances (All advances will have to be handled directly between client and shipper/broker;
- Handling and storage of paperwork (All documents will be sent to client unless other arrangements are made)
- DOT compliance issues; and Spike insurance (Unless other arrangements are made)

V. Governing Law

This agreement shall be governed by and constructed in accordance with the laws of the state of Texas without giving effect to any choice of law or conflict of laws provision rule (whether the state of Texas or any other jurisdiction) that would cause the application of the law of any jurisdiction other than those of the State of Texas.
